Profiles

Information given when signing a contract, or requesting a service, is used to build a client profile. Such profiles may include name, phone number, address, e-mail, and other such information willingly given by the client. We store such information through log files to create an online client profile. This profile is used to tailor a user's visit to our Web site, and to provide services such as online ordering. However, we do not share any personal information contained in your profile with other third parties.

Log Files

Like most standard Web site servers we use log files. This includes internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, platform type, date/time stamp, and number of clicks to analyze trends, administer the site, track user's movement in the aggregate, and gather broad demographic information for aggregate use. IP addresses are not tied to personally identifiable information.

Irene Jones Photography may send automated responses generated by the website in response to user input.
